


Elements Testing Flow Chart

These samples of Pb/Cd/Hg were dissolved totally by pre-conditioning method according to below flow chart.





Hexavalent Chromium (Cr(VI)) Testing Flow Chart





PBB(s)/PBDE(s)/Phthalates Testing Flow Chart






